IP-addresses	Tracking visitor statistics
Company name	To identify you as a prospect or customer, for our records and to comply with legal administrative obligations
Name contact person	To identify you as a prospect of customer and to be able to communicate with you personally
Gender	To communicate with you in the right way
E-mail	To be able to reply your requests through the contact form of our website and for further correspondence regarding your request
Phone number	To be able to contact you regarding your request
Website	To take note of your business and industry, so we can reply to your request and questions adequately
Country	To be able to check the proper legislation regarding your enquiry

We only use your data for the above-mentioned purposes. In the following cases it may be necessary to pass you data to other parties:

1. SUPPLIERS (AMONGST WHICH 'PROCESSORS'):

We have established the access of these parties to your data in 'processor agreements', in which we agree that these parties will only view your data occasionally and only when necessary. Furthermore we agreed that your data will never be used for their own purposes, nor will they be provided to third parties.
